INTRODUCTION

The Story as to how this Diary came into our possession is fascinating and to this day much remains a mystery.

In the nineteenth century our branch of the Unwin family lived in Shipley, outside Bradford in the West Riding of Yorkshire. My Great Grandfather, John Denby Unwin (who had been born in 1847) was sent by the Mill for which he worked (probably C F Taylors) to Dalry in Ayrshire to become the Overseer at a Mill that they built there and he and his family lived at Bridge End Cottage. My Grandfather, Dave Unwin, the fifth child and fourth son was born there on 16th September 1878. As a young man he trained as a Carpenter and spent some time working in South Africa. In 1908 he decided to go to America and landed in Halifax. Nova Scotia. Canada in March 1908. He settled in Spokane, Washington State in the U.S.A and there he met Elizabeth Turner of Barrow-in-Furness, Lancashire and they got married on 1st August 1910. They decided to live in Canada and crossed the border to Vancouver, British Columbia. It was here that my father. Thomas Denby Unwin, was born on 12th August 1911 and his sister, my aunt. Sophia Alice Unwin arriving on 18th September 1913. The family decided to return to England and arrived on the 'Empress of France' at Liverpool on 3rd December 1919. They lived in Shipley but on 1st January 1922 my Grandmother died and Dave Unwin was forced to split his family. My aunt went to her mother's relatives in Barrow-in-Furness and my father to his father's relatives in Shipley. Dave Unwin himself came to London to seek work. Whilst so working he was sent to Ken Wood House in Hampstead, North London (the home of the Guinness family). It was here he met Alice Horler, a maid from Single Hill near Bristol. They were married at St Pancras Register Office on 25th April 1925 and the family was re-united and home was set up home at 74 Hillside, Stonebridge.

During the course of his career Dave Unwin rose from Carpenter up to General Foreman (today he would be the Site Agent). It must be remembered that at that time the General Foreman would have been the governor on the site. He would have worn a bowler hat (a sign of his authority) and would be known as 'Mr Unwin'. Few people, if any, on site would be privy to his Christian name. On one of his jobs, I believe in Oxgate Lane, Cricklewood, and probably in the 1930's, one of the operatives came to him with a diary that he had found on site. Because it had the name John Unwin in it he presumed it belonged to my Grandfather. In practice Dave Unwin knew nothing about it and was not even sure to who it belonged - although it was obviously a member of our family.

My mother read the diary and did some detective work from it and we believe that it belonged to one of Dave Unwin's cousins. Currently my nephew, Tom Hughes, is researching our family tree and we now know that the man who wrote the diary was one of my grandfathers cousins - John Unwin who was born about 1867 (so he was 30). He married Louisa Gilbert in early 1895.

What will always be a mystery is how it travelled from Saltaire in 1897 to London some 30+ years later and yet stayed in very good condition. - Dave Unwin (Grandson of Dave Unwin above and third cousin of John Unwin) - 2009

THE DIARY

In the following transcription if I am unsure of a word or phrase there will be a ? after R. U, in the Diary is Robert Unwin, John Unwin's elder brother who went to America in 1897. J.U. is, I believe, John Unwins younger brother, Joshua Unwin who lives in Bridport, Connecticut and works there for Salts Textile Manufacturing Company. The 'Powers' mention in the addresses and the text (for example R.. P.) are probably cousins - John Unwin's mother was Charlotte Power before her marriage. References to 'Farrars' are also cousins since John's father had a sister, Pamela Unwin, who married a Thomas Farrar and had 9 children.
